ANY CHANGES TO THIS RIDER MUST BE MADE IN WRITING AND APPROVED BY ARTISTS' REPRESENTATIVES. This rider forms an integral part of the attached contract. The rider must be signed and returned with the contract by the stated date in the contract.

ADVERTISEMENT/BILLING OF ACT

Please be sure of the correct advertisement and/or marquee billing for Mysterious Ways. Mysterious Ways is a U2 TRIBUTE band, not a "U2 cover" band, with the official name being:

MYSTERIOUS WAYS – AMERICA'S U2 TRIBUTE BAND

Mysterious Ways will provide purchaser posters. High-resolution graphics will also be provided that may be used in your own designs so long as it uses the bands official name.

LOAD-IN/SET-UP

Mysterious Ways brings its own lighting to shows, as well as a video projector/screen setup to augment existing venue's lighting. Therefore, Mysterious Ways needs up to 2 hours to set up when not providing a PA/Sound System. When providing a PA/Sound system, the time needed may be up to 3 hours.

LOAD-OUT/TEAR-DOWN

Mysterious Ways needs to have up to 1½ hours to tear down/load-out when providing a PA/Sound System and up to 2 hours when providing a PA/Sound System.

BACKGROUND MUSIC/SUPPORT ACTS

Purchaser shall not play any recorded U2 songs once set-up has started. Support acts shall not play any U2 songs. Also, no **HEAVY METAL** support acts.

SECURITY

The purchaser shall provide both reasonable and adequate security for both Mysterious Ways and the audience.

DRESSING ROOM

Purchaser shall provide at least 1 safe, clean, dressing room with four (4) clean towels for Mysterious Ways' sole use. Dressing room must be locked or guarded to ensure safety of Mysterious Ways' belongings.

ACCOMMODATIONS

If performance results in an overnight stay, a minimum of two (2) business class hotel rooms, including 4 beds, will be provided by purchaser. Hotel should be in close proximity to venue. A buy-out of \$95/room may also be arranged.

MEALS/REFRESHMENTS

Unless otherwise indicated, Purchaser will provide an allowance of hot and cold beverages in the dressing rooms for the sole use of band and crew members. Special arrangements shall include: minimum of 12-8 oz. bottles or 4 pitchers of water and three alcoholic drinks per band member during show. In venues where food is served Purchaser shall provide, free of charge, 1 meal each for 4 band members with meals not exceeding the equivalent of \$20.00 (USD) per meal.

COMPLIMENTARY TICKETS

The purchaser shall make available (10) complimentary seats per show to Mysterious Ways for their use. Please note that the band uses complimentary tickets in trade for street level publicity and marketing of each event.

SOUND SYSTEM

If purchaser provides PA/Sound System, it should be capable of handling the specific venue. Minimally, the system should have a 16 channel mixing board with at least two effect units (reverb and delay), one floor monitor, and appropriate mic's and mic stands as outlined in the Mysterious Ways Input/Monitor list. Mysterious Ways will provide a 16-channel splitter snake and on-stage in-ear monitoring station.

DANCE FLOOR

Mysterious Ways requests that there be an unobstructed "dance floor" immediately in front of the stage. No tables or chairs up front.
